CAPP Beach Dog Patrol Rules

The Dog Patrol program is for the sole purpose of deterring waterfowl from the beach. A constant presence of dogs, on a property, has shown to effectively deter waterfowl.

- Only dogs with Patrol Permits, in good standing, are allowed on the property and ONLY when other members are not on the property.
- Only dogs with Dog Patrol Permits, in good standing, are allowed and ONLY when other members are Patrol times are from sunrise to 9 a.m. and 8 p.m. to sunset ONLY. If a member arrives while the dog is patrolling, the dog must be leashed and removed from the property immediately. Members must wait until the dog is leashed and removed before entering the property. Members are asked to avoid the beach, prior to 9 a.m., to allow affective waterfowl deterrence daily.
- Only one member family is permitted on the beach with their dog(s). Please limit your time to 30 minutes to allow other members the opportunity to use the beach for their dog. Members always take priority over dogs on the beach.
- Dogs are NOT permitted to harm waterfowl...this is a deterrent only.
- CAPP Beach does not actively supervise dogs on patrol. Anyone using this area does so at their own risk. While patrolling the beach, owners/guardians are assuming the full risk of any injuries, damages or loss connected with their dog. You will be held legally and financially responsible for your dog and any injuries, damages or loss caused by them.
- Dogs that have been declared aggressive or dangerous (by CAPP or any other municipality) are prohibited. It is
 your responsibility to advise CAPP if your dog has been declared aggressive or dangerous by a municipality. Any
 dog showing aggression towards people or other dogs, as determined by CAPP, will be removed from the property
 and not permitted back.
- Digging is not permitted. Guardians must fill in any holes their dog may dig, while on the property.
- Dogs in heat are not permitted.
- All guardians must have proof of their dog's current rabies and distemper vaccination, as well as Jefferson Township Dog License.
- Leaving dogs unattended is prohibited. Guardians must remain on the property with their dogs at all times.
- Dogs must be leashed when entering and exiting the property. Dogs must be at voice command at all times. The gate must be closed while dogs are on patrol.
- Non-Member's dogs are not permitted to patrol as a guest. Violation of this will revoke your permit.
- You must clean up after your dog. Do NOT use beach garbage cans to dispose of your dog's "droppings". Doggie Waste bags can be found on the gate, at the entrance of the property. Please take it with you for proper disposal. Please be advised that CAPP is not a dog park.
